SERVICE PROVIDED

The company's mission is to provide effective mental health services and treatment to adolescents and adults to enable individuals with significant psychiatric functional limitations to achieve and maintain community stability and independence in the most appropriate and least restrictive environment. Our counselors collaborate and coordinate with other case involved service providers and professionals, such as: attorneys, school personnel, social workers, and probation counselors. By facilitating an open dialogue between these entities and the client families, the treatment planning process directly addresses the service recipient's needs and expressed preferences of the family. This process also identifies community resources and services that can be of benefit to both the clients and their respective families.

- FSI counselors are Bachelor and Master's level counselors.
- Counselors are available 24 hours, 7 days a week for Crisis Intervention.
- Counselors at Foundation Stones, Inc. provides up to 20 hours weekly to every client. We are committed to a strengths based, family systems approach, acknowledging that no family member stands alone and we believe in utilizing the natural resources available to the family.
- Counselors stand as advocates for the client within the community to create a stabilized environment.
